Steps to filing Candidacy for any of the Generalist Right of Way Certifications or Designation

1. Read through specific program brochure and description
2. Read through specific Career Path Overview
3. Determine education and right of way experience eligibility
4. Meet with your local Chapter PDC Chair to verify qualifying experience.
5. Have your local Chapter PDC Chair complete and sign verification
6. Submit candidacy form with appropriate fee to IRWA headquarters

Applications will be processed in order of receipt. Processing of candidacy applications may take up to 4 weeks
