FHVVA Manual Revisions, Credibility and USPAP Appraisal Review Issues



Extensive change is the nature of all business today, appraisal and waiver valuation both being amongst those changes. Though change is nothing new, the rate of it continues to accelerate.

Illinois Department of Transportation (IDOT) is contributing to positive change relative to policies and procedures within and related to the appraisal profession. Recent changes implemented by the FHWA and 49 CFR Part 24 relative to valuation waivers will be discussed as well as their impact on all DOTs. We will also discuss how we are updating the Land Acquisition Policies and Procedures Manual at IDOT to reflect these changes. These changes are, in part, being utilized to leverage and grow talent to IDOT for potential staff positions and consultants, as we have a significant shortage of available appraisers and review appraisers with a knowledge of eminent domain.

The presentation includes various updates to obsolete, oftenutilized appraisal language that is inconsistent with required practices in FHWA, 49 CFPR Part 24, Uniform Appraisal Standards for Federal Land Acquisitions/Yellow Book, USPAP, Illinois Law, Illinois Administrative Code, EPAS and IDOT's Land Acquisition Policies and Procedures Manual, and lastly, applicable case law on both a federal and state level.

Discussions include use of correct terminology and definitions to provide a defensible opinion of value and when the use of them incorrectly utilized may deter the credibility of the appraisal. We will also discuss complex vs. noncomplex assignments and how they relate to USPAP to correlate to whether the appraisal is an appraisal report vs. a restricted appraisal report. Competency issues, rounding, templates, retrospective dates, extraordinary assumptions, project influence, hypothetical condition, excess vs. surplus land, highest and best use, assemblage and their impact will be briefly explored. Data verification requirements and appraisal practice limits will be presented.

A multifaceted approach for DOTs, as discussed in this presentation, will assist in increasing minimum education and competency levels. IDOT's existing and new appraisers and review appraisers are currently going through a reapproval/approval process through Engineering Prequalification and Agreement System (EPAS) with a requirement for an ongoing renewal process. Appraisers and review appraisers must meet minimum competency and experience requirements and are required to take continuing education relative to eminent domain. In this effort, IDOT has developed CE classes awaiting regulatory approval from IDFPR, our sister state agency that monitors appraisal licenses and approval of continuing education. IDOT is developing a program to train appraisers and review appraisers to become proficient in eminent domain and overlapping requirements. \bigcirc



Right of Way Rodeo: Wrangling Utility Upgrade Obstacles

Heirs' Property, Partition Suits and Right of Way

What exactly is heirs' property? What are the effects — both intended and unintended — on certain segments of the American population? Why does it disproportionately impact certain groups? Karla Carter, Dominion Energy senior counsel, and Ross Greene, chair of Pender & Coward's Eminent Domain/Right of Way Practice Group, will discuss these topics and more, including how heirs' property intersects with partition suits and right of way acquisition and what can be done to make that intersection more just.

Heirs' property (sometimes known as family land) is property that has been transferred to multiple family members by inheritance, usually without a will. For the heirs, owning property as tenants in common without a clear title can lead to many challenges. They may be unable to access loans and mortgages, apply for USDA grants or loans or build wealth from the land by engaging in commercial activity, such as selling timber or other resources — all of which require proof of ownership. Heirs' property can also make for a particularly difficult interaction with right of way acquisitions, including the heartbreaking situation where someone has lived on a property for generations but cannot negotiate effectively for just compensation either because they have a small percentage interest or because their ownership interest cannot readily be ascertained from the local public records.

What can right of way professionals do to become informed about and combat heirs' property problems like this? Come to this session and find out! •

How the Virginia Passenger Rail Authority (VPRA) is Transforming Rail in Virginia

Virginia is embarking on a transformative journey to revolutionize its passenger rail network. The Virginia Passenger Rail Authority (VPRA), established to oversee and promote rail initiatives, is at the forefront of this ambitious endeavor known as Transforming Rail in Virginia (TRV). This \$5 billion initiative aims to expand and modernize rail services through capital projects and ROW acquisitions, offering Virginians more efficient and sustainable travel options.

Governed by a diverse board appointed by the governor, VPRA partners with operators like Amtrak, Virginia Railway Express and Norfolk Southern, as well as the Department of Rail and Public Transportation. As a quasi-state agency, VPRA uniquely owns, acquires and develops rail infrastructure.

This presentation will provide right of way (ROW) and land professionals with an insider's perspective on how the VPRA:

- Has TRV initiatives that are reshaping Virginia's transportation landscape, and the role ROW professionals have in this transformation
- Manages and funds ROW acquisitions
- Oversees rail development
- Ensures that rail development projects comply with regulations to minimize negative impacts on human health and the environment
- Collaborates with rail operators, government agencies and additional stakeholders to expand rail services and reshape rail transportation in Virginia and beyond. ♥

ALTA/NSPS Land Title Surveys: Essentials & Misconceptions

This session explores the critical role of ALTA/NSPS Land Title Surveys, the national standard for real estate transactions.
