This has been an interesting and exciting year! IPEC is making awesome strides in creating a process that will track course updates and revisions as well as creating a method of getting them updated in a timely manner. And dear to my heart — the IGC has taken up the call for developing a five-year strategic plan! This will provide a basis for developing training, guidelines and expectations for both the Mentors and Mentees in the program. This is a valuable program in the development of our future industry leaders and should be continued and supported.

We need to create leadership modules not just to develop the Chapter leadership, but also to make sure that we are providing our members with the skills they need to excel and move up in their careers. Many agencies are looking for project management skills and to stay relevant; we need be providing the soft skills of leadership (team building, communication, etc.) as well as skills such as time management and budgeting.

All of these things will take time to develop, but the key is to take action and continue to push on. This is where my experience and skill set can be put to work in order to help keep these initiatives moving forward. I have developed and run multimillion dollar projects and have delivered on time and under budget with diverse stakeholder groups. I am a listener, a collaborator, a planner and a solution-oriented leader.
