The Opening Ceremony kicked off with Jon Vaughan, SR/WA, conference co-chair, stepping on stage to welcome everyone to conference. Moments later, his co-chair, Richard Pittenridge, SR/WA, joined him with a grin, proudly lugging an enormous hiking backpack over his shoulders as a clever salute to the endless hiking trails that Denver is famous for. The co-chairs then invited Past International President Lee Hamre, SR/WA, Kristen Bennett, SR/WA, and friends to join the stage and give a stunning rendition of the national anthem during the presentation of the flags.

Richard and Jon then ran through the list of festivities, highlighting the education sessions, networking events and more before welcoming International President Judy Jones, SR/WA, to the stage to call the Annual Meeting of the Members to order. Judy acknowledged the 2022-2023 International Executive Committee, Advisory Council and International Governing Council. "Thank you for your efforts in developing the solid foundation on which we continue to build this Association," she remarked.





Going Above and Beyond

Judy then invited President-Elect Fred Easton, Jr., PLS, SR/WA, to the stage to present the Lifetime Achievement Award to Ernest (Ernie) Franzoy. Kevin Winner, SR/WA, accompanied him on stage to share a story of Ernie’s dedication to the Association. Clutching the award, Ernie smiled out from under the brim of his iconic cowboy hat and addressed the crowd, “I just do what I thought should be done to make this Association one of the greatest things in my life. You only get out of something what you put into it. So, anybody can win this, all you gotta do is strive to be the best you can be.”

On the Horizon

Next, Executive Director Tim Drennan, CAE, gave the State of the Association Address. Tim shared how staff at Headquarters have been working closely with leadership to meet marketing and education goals. He stated that the Association has experienced a growth in membership since October, resulting in a membership income of \$1.5 million. “As a result of the collaboration efforts between Chapters and staff, I am proud to say the Association has exceeded our course scheduling goal for the second year in a row. And for the upcoming year, we’ve already scheduled more than 350 courses,” Tim remarked. He also announced that IRWA currently has 3,083 certified and designated members, which calculates to 42% of the membership holding at least one IRWA credential. He concluded by emphasizing the unlimited opportunities that lay ahead for the Association and

that anything was possible with members and staff continuing to work together to achieve goals.

Judy returned to the stage to give the State of the Profession. “In my 25+ years in this industry, I have never witnessed the demand for our services that is present today,” Judy remarked. She spoke on how the Infrastructure Investment and Jobs Act funding has provided a catalyst for projects across many areas of the industry, including the rise of the green and renewable energy and the modernization of municipal and community-owned natural gas distribution pipes. Finally, she shared how IRWA is focused being a valued partner in providing educational offerings to mentor new talent to the industry and stressed the importance of training the future group of right of way professionals. “IRWA, like never before, is a member-led and member-focused organization, dedicated to meeting the needs of our members.”

Judy then invited Lerato Mokgwathleng and Lourens Nel from Chapter 83 to join her on stage for the signing of a renewed agreement with South African Right of Way Association (SARPA) in recognition of SARPA’s many contributions made to the right of way profession and IRWA.

The ceremony concluded with John Register, a two-time Paralympian, Persian Gulf War veteran and TEDx Motivational Speaker. John’s inspiring speech set the tone for the rest of the week, leaving attendees motivated and ready for the events to come.



AWARDS CEREMONY

This year, there were a total of 93 individuals between May 1, 2022, and April 30, 2023, who received their prestigious SR/WA designation. All smiles, the recipients took the stage one by one to shake hands with International Professional Education Committee (IPEC) Credentialing Vice Chair Elizabeth Smith, SR/WA, be congratulated by IPEC Chair Janet Walker, SR/WA, and take a picture with International President Judy Jones, SR/WA.

Next, the Right of Way International Education Foundation (RWIEF) President Leslie Finnigan, SR/WA, proudly announced a new scholarship named in memory of Past RWIEF President Carol Croft, SR/WA, and explained how the funds would be dedicated to those close to achieving their SR/WA (for more information on this scholarship, please see the July/August 2023 issue of Right of Way Magazine). "I know Carol is dancing a jig up in heaven about this," Leslie said, throat tight with emotion. The crowd erupted in applause as Judy and Leslie signed the MOU agreement and shared a warm embrace in memory of their dear friend Carol.

Next, the emcee for the event this year was comedian Brad Montgomery, who charmed the crowd with his quick-witted commentary and clever magic tricks before inviting International Nominations & Elections Chair Kris Koehler, RWP, to the stage. "The Awards presented today symbolize the best of the IRWA and the professionals in this industry. Every recipient and finalist should be proud of their accomplishments," Kris remarked.

The excitement and energy in the room was infectious as each winner was announced. The anticipation climbed as the ceremony concluded with the final awards for the afternoon. Janet Walker, SR/WA, accepted the Ronald Jourdan SR/WA Advancement Award. "I'm very honored to receive this on behalf of everyone I've worked with over the decades," Janet said as she smiled out to the crowd.

Past International President Jim Struble, SR/WA, presented the Dan Beardsley Memorial IRWA Builder Award to James H. Finnegan, SR/WA, this year after sharing some of James's finest accomplishments. As James took the stage, he quipped, "Well, Jim said an awful lot, and my answer to what he said is 'Yes that was me, but it took a long time.'" He took the time to honor the late Past International President Dan Beardsley, SR/WA, and concluded by thanking the committee for the award.

This year, the highest honor, the Frank C. Balfour Professional of the Year Award was presented to Cyndi Whelpley, SR/WA. "I couldn't do this without the professionals [who] surround me all the time," Cyndi said before thanking several people in her life including her family, mentors and lifelong friends who helped guide and support her to this very moment.

The recipient of the Website of Year award went to California Inland Empire, Chapter 57, Region 1.





As the summer heat dissipated with the setting sun, attendees gathered in front of the stage to enjoy the live music provided by That Eighties Band.

Meanwhile, on the opposite side of the field, others were enjoying the Dunk Tank festivities, sponsored by Farnsworth. By donating to right of way education, participants could purchase balls to throw at the target in a playful attempt to soak their chosen victim. Prior to the event, attendees and members voted on which IRWA leaders they most wanted to see dunked. BOARD OF DIRECTORS

International President Judy Jones, SR/WA, called the annual Board of Directors meeting to order on Wednesday, June 28, 2023. After the minutes of the previous annual meeting in Cleveland were approved, International Treasurer Koby Godwin, SR/WA, presented the proposed 2023-2024 budget. The motion to accept the 2023-2024 budget, which had been circulated to all 10 Region forums, was approved.

Education Foundations

Judy recessed the meeting and invited Right of Way International Education Foundation (RWIEF) President Leslie Finnigan, SR/WA, to the stage to discuss Foundation updates. Leslie thanked the members, leadership and industries for their support of RWIEF and continued by sharing more about her journey with the Foundation. She touched on the huge impact Past RWIEF President Carol Croft and how she's still missed, but the Foundation is focused on carrying on her vision and mission.

“This has been a busy year. Our purpose to use money to further education initiatives and scholarships has been the focus,” Leslie stated, also adding that the Foundation has committed to almost a half a million dollars toward right of way education this year. She continued, noting that the funds went toward multiple scholarships, including the Leaders Light the Way 2.0 scholarship and the new Carol A. Croft Finish Line Scholarship. She also shared that the Monday Night Event was a success and thanked all who helped plan the event. Leslie then invited those who requested an opportunity to donate to the Foundation to step forward and do so. Many donated generously to right of way education. “We can’t thank you enough — your support means everything.” Leslie concluded.



Next, Canadian Right of Way Education Foundation (CRWEF) President Nancy Sinclair took the stage to give their Foundation update. Nancy thanked everyone who came out to support the Canadian Hospitality Suite, which had taken place the night before. After introducing CRWEF's Board of Directors, she went on to speak on the donations to the Foundation. "Every donation that is made here today, that is made online when you renew your membership — that money goes directly into the delivery of the programs we all enjoy. So, thank you very much, we appreciate your continued support." Nancy continued by announcing that CRWEF had agreed to a commitment of \$3,000 every year for three years to each of the Canadian Chapters to award a member-based scholarship. She also spoke of the Foundation's commitments to education by sponsoring seminars, webinars, courses and more. Members in attendance then stepped to the microphone to donate to CRWEF in support of right of way education.



Business and Nominations

General Counsel Dave Arnold, Esq., SR/WA, was then invited to present the resolutions. Two were offered this year: Bylaws Resolution 2023-01, which was passed, and Bylaws Resolution 2023-02, which was rejected (more information on these resolutions can be found on irwaonline.org on the Board of Directors 2023 page).

Judy then returned to the stage to present a check to the conference co-chairs Richard Pittenridge, SR/WA, and Jon Vaughan, SR/WA, and Chapter 6 president, Lisa Stringer, SR/WA, for hosting the conference in Denver this year. The three accepted the check and thanked key people who were a part of the planning process. Next, the co-chairs for the 2026 annual conference, Jake Farrell, SR/WA, and Mindy Leadholm, SR/WA, gave a brief preview of what to expect in Omaha. "We know 2026 is still a few years away, but we are really excited to start planning a really exciting conference."

Kris Koehler, SR/WA, International Nominations and Elections Committee chair, then presented the nominations for the International Executive Committee. Denise Skinner, SR/WA, Koby Godwin, SR/WA, and Dan Bucan, SR/WA, were up for reelection and were confirmed. Cyndi Whepley, SR/WA, joined the IEC as International Secretary. It was announced that Dave would continue as General Counsel for 2023-2024.

International Secretary Dan Bucan, SR/WA, presented the International Region Officers, while President-Elect Fred Easton, Jr., PLS, SR/WA, announced the 2023-2024 leadership appointments and the International Service and Industry Committee chairs and vice chairs as approved by the IEC. The entire slate then came forward to be sworn in by Past International President Lee Hamre, SR/WA.

Working Toward a Future Together

As IRWA's next International President, Fred addressed the members and shared his insights and plans for the next year. He started by thanking the Board for their volunteer leadership and for dedicating their time and experience. "Your impact ethically sustains and grows this Association. Being catalysts for positive change, driving progress, innovating our industry and leading our profession will stretch so much further than you can ever know or see directly."

Fred went on to emphasize the importance of growing the Association and expanding the membership base. He also noted how marketing and outreach are essential factors in achieving that growth — increasing social media presence, holding more webinars and partnering with other professional organizations are ways to help promote IRWA. He closed by stating that the spirit of mentorship was at the center of the Association and the key to nurturing future leaders.

"My friends, I urge each and every one of you to seize the opportunity before us and commit ourselves to the effort to grow and sustain the International Right of Way Association," Fred remarked. "Together, we can embrace this challenge and create a legacy that will be remembered for generations to come."
